Komal Anand, Additional Secretary, Ministry of Culture, Government of India.

Welcoming the Members, the Member Secretary apprised them of the aims and objects of the Scheme and also the maximum limit of the Financial Assistance admissible under the scheme. The members were informed that an amount of Rs.9.58 lakhs (2001-2002) is available after meeting the committed expenditure of last financial year (2000-2001).

Subsequently, proposals received from different voluntary organizations/ universities/ individuals seeking financial assistance were taken up for consideration within the parameter of the scheme and the following decisions were taken:

1. Grants Committee recommended Rs. 13.70 lakhs to 21 organisations out of 112 organizations/ universities/ individuals (Annexure-I).
 2. The Grants Committee did not recommend financial assistance to 91 Organizations/ universities/ institutions/ individuals due to reasons such as non-receipt of State Government/ Archives recommendation pending utilization Certificate for the grants given earlier and in the absence of information about the Manuscripts/ Rare Books, etc. (Annexure II).
 3. The Members of the Grants Committee also observed that large number of proposals were recommended by the Karnataka and Central State Government/ Archives without verifying the antecedents of NGOs. Most of these institutes do not possess manuscripts, rare books and, therefore, decided that proposals of only deserving NGOs be recommended for financial assistance under the scheme.

The Grants Committee unanimously decided that letters may be addressed to the Chief Secretary of Govt. of Karnataka and Orissa from the Additional Secretary (C) stressing upon the need to verify the activities of the NGOs while proposals are recommended by the State Government/ Archives for grant under this scheme.

4. The Grants Committee also decided that the request of the Tamil University, Thanjavaur, Tamil Nadu for waiving of 6% Penal Interest i.e. Rs.4,290/- may be referred to IFD, Ministry of Culture for consideration.
5. The Grants Committee also acceded to the request of Jamia Hamdard (Deemed University) for diversion of grant amount of Rs.1.80 lakh sanctioned for microfilming of manuscripts during 1990-2000 for lamination of manuscripts.

The meeting concluded with a vote of thanks to the chairperson.
