Welcoming the members, the Member Secretary apprised them of the aims and objectives of the scheme and also the maximum limit of the Financial Assistance admissible under the scheme. The members were also informed about the availability of funds for the scheme during the financial year 2004-2005.

Subsequently, proposals received from different Voluntary Organizations/Universities/Individuals seeking financial assistance were taken up for consideration within the parameters of the scheme and the following decisions were taken:

- 1. Grants Committee recommended Rs.28,60,000.00 (Rupees Twenty Eight lakhs and Sixty thousands only) to 39 organizations out of 169Organizations/Universities/Individuals (Annexure I)
- 2. The Grants Committee did not recommend Financial Assistance to 130 Organizations/Universities/Individuals/ Institutions due to reasons such as non-receipt of State Government/State Archives recommendation, pending Utilization Certificate for the grants given earlier and in the absence of information about manuscripts/rare books etc in their custody (Annexure II)

The Chairman desired that new proposals for financial assistance should be encouraged and at least 5% cases to whom the financial assistance has been given should be test checked to monitor the progress of their work.

The meeting concluded with a Vote of Thanks to the Chairman.
