Welcoming the Members, the Chairman apprised them of the aims and objectives of the scheme and also the maximum limit of the Financial Assistance admissible under the scheme. Subsequently, proposals received from 138 Voluntary Organizations/ Universities/ Individuals seeking financial assistance were taken for consideration within the parameters of the scheme and the following decisions were taken:

1. Grants Committee recommended Rs.24,67,000/- (Rupees Twenty Four Lakhs Sixty Seven Thousand only) to 45 Organizations/ Universities (**Annexure-I**)
2. The Grants Committee did not recommend Financial Assistance to 93 Organizations/ Universities/ Individuals etc. due to pending utilization certificate and in the absence of any specific information about their holdings viz. Manuscripts/ rare books etc. The list of these rejected/ deferred cases is given at (**Annexure - II**)
3. The Grants Committee Unanimously decided to consider all the applications received till 4 November 2007, though the cut off date for the scheme of application was 15 June 2007. All the applications received after the Grants Committee meeting (i.e. 5 November 2007) shall be placed before the next meeting of the Grants Committee to be held in January 2008.

As regards the advertisement inviting applications for financial assistance under the Scheme of Financial Assistance for Preservation of Manuscripts/ Rare Books to Non-Governmental Organizations, it was decided that sufficient time should be given for submitting the applications and also for scrutiny of the proposals by the recommending authorities and instead of cut off date of receiving applications the following lines may be inserted in the advertisement: "All the applications for Financial Assistance may be submitted within six weeks from the date of publication of the advertisement".

4. The Committee also examined 3 cases out of which 2 cases (Nos.1 & 2 below) were deferred/ rejected by the Grants Committee in its meetings held on 29-30 August 2006 and 21 February, 2007 due to lack of details about their holdings and one case (No.3 below) where grant was recommended subject to inspection during 2006-07. The details of these cases are furnished below :

The Grants Committee recommended Rs.45,000/- as per the details of holdings after inspection.


The Grants Committee recommended Rs.75,000/- as per the details of holdings after inspection.

inspection.


5. The Grants Committee also discussed the matter regarding copies of publication to be forwarded to NAI after publication of book by the grantee institute/ individual. It was decided that a clause may be added in the scheme that "A Grantee Institution/ Individual may forward one copy of a publication free of charge to this department duly acknowledging the grant given by NAI if 500 copies are published and 2 copies of a publication if more than 500 copies are published".
6. A detailed letter from the Chairman, Grants Committee may be sent to the Member Secretaries of all the State Level Screening Committees and Directors/ Head of State/U.T. Archives instructing them to scrutinize all the applications properly so as to ensure that the proposals are within the purview of the scheme and complete in all respect.
