NATIONAL ARCHIVES OF INDIA**MINUTES OF GRANTS COMMITTEE MEETING FOR THE SCHEME OF FINANCIAL ASSISTANCE FOR PRESERVATION AND CONSERVATION OF MANUSCRIPTS, RARE BOOKS, OLD AND RARE DOCUMENTS, RECORDS OF HISTORY**2014-2015

Meeting of the Grants Committee for the above scheme was held on 27 August, 2014 in National Archives of India, New Delhi under the Chairmanship of Shri V. Srinivas, Director General/Joint Secretary, National Archives of India, Ministry of Culture. The present meeting has been convened in response to the advertisement published on 21 May, 2014.

2. The members who were present in the meeting is at **Annexure-I**

3. Welcoming the Members, the Chairman apprised them of the aims and objectives of the scheme and informed the Committee that the maximum limit of the grant is ₹10.00 lakhs per project per year. The Chairman emphasized the need for a proper monitoring mechanism for better utilization of the grant amount released. He also encouraged support for conservation and restoration of Manuscripts, Rare Books etc., instead of purchase of equipments for the same. Emphasis was also made for promotion of tissue lamination of the records. Subsequently, under the Chairmanship of the Grants Committee all the 48 complete cases in Part A of the Agenda that includes Part A-I 30 cases from State Other than North-East and Part A-II 17 cases from North-East State were taken up for consideration and the following decisions was taken by the Grants Committee.

Part A- I-States other than North-East:- The Grants Committee considered 30 proposals which were complete in all respect, out of which 20 cases from the State of Delhi, Gujarat, Maharashtra, Odisha, West Bengal were recommended.

Grants Committee recommended a total grant =₹58,17,000/-

75% Central Govt. Share including 2 cases 100% share is ₹46,12,750/- (₹43,62,000/-+₹10,00,000/-+₹3,41,250/-) of the above amount of ₹58,17,000/- and thus the 1st installment of ₹23,06,375/- would be released to the Grantee who have submitted the complete Bond and other papers. The 2nd installment would be released as re-imbusement once the Utilization Certificate of the entire grant is submitted by the Grantee.


