## **Empanelment of Firms for Printing**

National Archives of India (NAI), an attached office of Ministry of Culture invites applications for empanelment of Organization/Agencies for Printing for NAI's Publications. The Panel of Firms would be valid for a period of one year, extendable up to three years. Retention of a firm in the panel would be inter alia subject to satisfactory performance.

Interested reputed Organizations/Agencies having proven experience (of minimum 5 years) in the relevant field and fulfilling the prescribed eligibility criteria may submit their profile along with all supporting documents in sealed envelope which should be super-scribed as "Empanelment of Firms for Printing". Sealed tenders should reach to Deputy Director of Archives or Assistant Director of Archives, National Archives of India, Janpath, New Delhi-110001 within three weeks of uploading of the notice on NAI website. Any profile received after that would not be entertained.

#### 1. Eligibility Conditions -

- (A) The Bidder should have over the last three financial years an average annual turnover of not less than Rs.50, 00,000/- (Rs.Fifty Lakhs only) from Printing. (Duly certified by CA with registration number and seal of the CA)
- (B) The bidder must have experience of minimum 10 years in the field of printing and publishing out of which at least 05 years experience must be in Central Government Ministries or Departments or Attached/ Subordinate Offices or Autonomous Institutions/ Universities/ Public Sector Undertakings of the Government of India or Government of NCT of Delhi or any other State Government or Public Sector Banks or Local Bodies or Municipalities. Copy of the Govt. work orders should be enclosed.
- (C) It should have at least one branch office located in Delhi. It may have its registered office anywhere in India.
- (D) It should not have been blacklisted over last five years (An undertaking in this regard will have to be submitted by the bidder at the time of bidding).

The validity of the above said certificates of registrations will be seen with reference to the last date of bid submission schedule. During the period of bid evaluation or the operation of the contract, if any of the above said certificates of registrations becomes invalid, the contractor will get one-month time to get the validity restored form the respective Agencies, failing which it will be treated as Contractor event of default.

The Director General, National Archives of India, reserves the right to reject the Organizations/ Agencies/Publishers and Printers from empanelment without assigning any reason thereof. The decision of the National Archives of India in this respect shall be final and binding.
